**THEREFORE THE FOLLOWING ARE HEREBY ORDERED:**

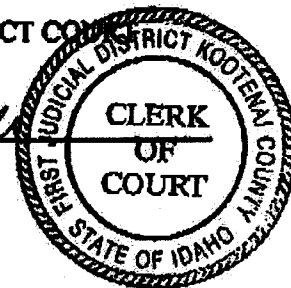
