

FINAL ORDER DISALLOWING WATER RIGHT CLAIMS

On February 19, 2019, the State of Idaho filed a *Motion to Disallow* the above-captioned water right claims. The *Motion* is filed pursuant to a stipulated settlement entered into by the parties. The Court has set forth the background behind that settlement, and the proceedings underlying that settlement, in two *Orders*. The first is the Court's *Order Denying Motions to Participate* entered in SRBA Subcase Nos. 63-33732, et seq., on July 8, 2019. The second is the Court's *Order Granting Motion to Alter or Amend Partial Decree* entered in SRBA Subcase Nos., 63-303, et seq., contemporaneously herewith. Rather than repeat the backgrounds set forth in those *Orders* the Court incorporates them herein by reference. A hearing on the State's *Motion* was held before the Court on July 16, 2019. For the reasons set forth on the record the Court in an exercise of its discretion granted the *Motion*.

Therefore, IT IS ORDERED that the State of Idaho's Motion to Disallow Water Right Claim Nos. 63-33732, 63-33733, 63-33734, 63-33737, and 63-33738 is hereby granted.

IT IS FURTHER ORDERED that the above water right claims are hereby **disallowed** with prejudice and shall not be confirmed in any partial decree or in any final decree entered in the SRBA, Case No. 39576, in whatever form that final decree may take or be styled.
