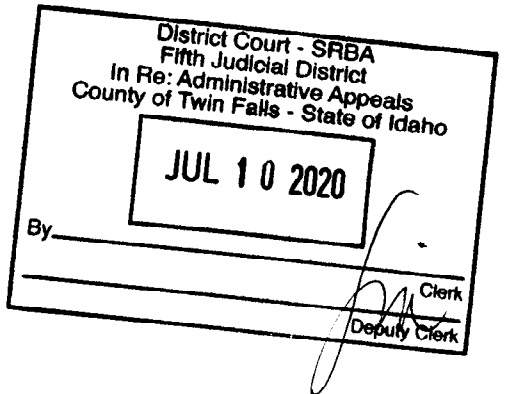

ORDER GRANTING PETITION TO INTERVENE




