DECLARATION OF COUNSEL IN SUPPORT OF UNOPPOSED MOTION TO MODIFY BRIEFING SCHEDULE

IN THE MATTER OF DISTRIBUTION OF WATER TO VARIOUS WATER RIGHTS HELD BY OR FOR THE BENEFIT OF A&B IRRIGATION DISTRICT, AMERICAN FALLS RESERVOIR DISTRICT #2, BURLEY IRRIGATION DISTRICT, MILNER IRRIGATION DISTRICT, MINIDOKA IRRIGATION DISTRICT, NORTH SIDE CANAL COMPANY, AND TWIN FALLS CANAL COMPANY

I, Elisheva M. Patterson, declare the following:

- I am an attorney representing Petitioner Idaho Ground Water Appropriators, Inc. ("IGWA") in the above-captioned matter.
- 2) Pursuant to this Court's August 16, 2023 *Procedural Order*, the Petitioner's opening brief is due within 35 days of the lodging of the settled transcript and record with the district court. The settled transcript and record were lodged with the district court on September 27, 2023, meaning that IGWA's opening brief is due November 1, 2023.
- On October 16, 2023, less than 21 days after the lodging of the settled transcript and record with the district court, IGWA filed a *Motion to Augment Agency Record or Present Additional Evidence* ("Motion to Augment").
- 4) On October 26, 2023, the Court issued a notice of hearing on the *Motion to Augment*, setting oral arguments on the motion for November 9, 2023.
- 5) There is good cause to extend and reset the briefing deadlines because IGWA's opening brief seeks to reference evidence at issue in the *Motion to Augment* but cannot do so without the Court's decision on the *Motion to Augment*. Accordingly, IGWA requests that the Court vacate the briefing schedule set forth in the *Procedural Order* until the Court rules on the *Motion to Augment*.
- 6) No extensions of time have been previously requested, and so no requests for extensions of time have been denied or granted.

- The parties to the above-captioned matter were consulted regarding this motion and all parties agree to vacating the current briefing schedule.
- 8) No alternate dates for when briefs become due are proposed as these alternate dates are subject to the Court's pending ruling on the *Motion to Augment*, of which the date of issuance is unknown. However, the briefing schedule contemplated in the Procedural Order and I.A.R. 34(c) will likely be applied and triggered by the Court's ruling on the Motion to Augment issuance date. Or, alternatively, based upon the date that Respondent Idaho Department of Water Resources and Mat Weaver elect to modify their actions and file any modifications or new findings with the Court, pursuant to Idaho Code § 67-5276(2). The proposed briefing schedule will likely be modified also because of the holiday season, over which briefs may be due.
- 9) After the issuance of the Court's decision on the Motion to Augment, the parties shall coordinate with one another and the Court to set a briefing schedule. The parties are known entities to this Court having brought judicial review before it numerous times in the past. To the best of my knowledge all parties have complied with the Court's procedural orders and have submitted briefs timely.
