IT IS FURTHER ORDERED that this Order to Show Cause must be served upon the Respondents or their attorney of record at least five (5) days prior to the date of Show Cause hearing.

IT IS FURTHER ORDERED that if the Respondents elect to product testimony and evidence at the hearing, or to cross examine the Petitioner and/or its declarants, they must give notice to the Court and the Petitioner at least 24 hours before the hearing and designate the person(s) sought to be cross-examined.
