



restraining and enjoining the Respondents from enforcing the June 28, 2021 *Final Order* from the Director of the Department of Water Resources, and enjoining the Director from curtailing Petitioner's members right to pump ground water in accordance with their respective water rights to prevent immediate and irreparable harm or injury and to maintain the status quo during the pendency of this action.

IT IS FURTHER ORDERED that this Order to Show Cause must be served upon the Respondents or their attorney of record at least five (5) days prior to the date of Show Cause hearing.

IT IS FURTHER ORDERED that if the Respondents elect to produce testimony and evidence at the hearing, or to cross examine the Petitioner and/or its declarants, they must give notice to the Court and the Petitioner at least 24 hours before the hearing and designate the person(s) sought to be cross-examined.
