Company.

On May 26, 2021, a *Notice of Appearance* was filed in this matter by the City of Bellevue.

On May 27, 2021, a *Notice of Appearance* was filed in this matter by the Big Wood Canal Company.

On May 28, 2021, a *Notice of Appearance* was filed in this matter by the Big Wood & Little Wood Water Users Association.

Pursuant to the *Procedural Order* issued by the Court on May 27, 2021, the Court will treat the *Notices of Appearance* as *Motions to Intervene*. The Court finds, following a review of the file, that the above-identified entities are real parties in interest to this proceeding, were parties to the underlying administrative proceeding from which judicial review is being requested, and have interests that could be affected by the outcome of this proceeding. The Court further finds that no party has objected to their participation in this proceeding. Therefore, in exercising its discretion, the Court finds that the above-identified entities are entitled to leave to intervene as parties to this proceeding.

Additionally, on June 25, 2021, the City of Pocatello filed a *Motion to Interevene* in this proceeding. The Court in an exercise of its discretion, having reviewed the *Motion* and the file, will grant the *Motion to Intervene* under Idaho Rule of Civil Procedure 24(b). The Court finds the *Motion* to be timely. This proceeding is in its earliest stages and no substantive rulings on the merits have occurred at this time. The Court therefore finds no prejudice to the other parties to this action. The Court finds the City of Pocatello claims an interest in this matter relating to the legal issues surrounding the Director's actions pertaining to water right administration, given that it holds junior water right in the Eastern Snake Plain Aquifer. The legal issues decided in this proceeding may have a precedential effect with respect to water right administration on the Eastern Snake Plain Aquifer. Therefore, in exercising its discretion, the Court finds that the City of Pocatello is entitled to leave to intervene as a party to this proceeding.

THEREFORE THE FOLLOWING ARE HEREBY ORDERED:

1. The *Motions to Intervene* filed by the following entities are hereby granted: (1) the Sun Valley Company; (2) the City of Bellevue; (3) the Big Wood Canal Company; and (4) the Big Wood & Little Wood Water Users Association.

2. The *Motion to Intervene* filed by the City of Pocatello is hereby granted.

3. All further captions used in this proceeding shall include the above-identified entities as Intervenors as shown above.
