On February 2, 2022, the Idaho Department of Water Resources ("Department") served its *Notice of Lodging the Agency Transcript and Record with the Agency* ("*Notice*") in this matter pursuant to I.R.C.P 84(j). The *Notice* gave the parties fourteen (14) days from the date of the *Notice* to file any objection to the agency transcript and record. On February 16, 2022, Bruce and Glenda McConnell filed *McConnell Objection to Agency Record* ("McConnell Objection").

RESPONSE TO OBJECTION

The McConnell Objection states that the *Declaration of Bryce Contor* should be excluded from the agency record. McConnell Obj. to R. at 3. The objection is based upon the hearing officer's *Order Denying Petition to Re-Open Hearing and Petition for Site Visit* and the Director's subsequent *Order on Exceptions; Final Order Approving Transfer*. *Id.* at 2. After reviewing both the June 21, 2021 Order Denying Petition to Re-Open Hearing and Petition for Site Visit and the November 2, 2021 Order on Exceptions; Final Order Approving Transfer, the Director reaffirms that the evidence presented in the June 1, 2021 *Declaration of Bryce Contor* was not admitted into the administrative contested case record and finds the exclusion of the *Declaration of Bryce Contor* from the agency record to be appropriate and reasonable.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that, upon the exclusion of the June 1, 2021 *Declaration of Bryce Contor* from the agency record, the agency transcript and record are now deemed settled pursuant to I.R.C.P. 84(j).

IT IS FURTHER ORDERED that, pursuant to I.R.C.P. 84(j), the McConnell

Objection and this Order shall be included in the agency record on the petition for judicial

review. The Department shall provide the parties with a copy of the settled agency

transcript and record.
