On May 21, 2026, the Idaho Department of Water Resources (“Department”) served its *Notice of Lodging the Agency Record with the Agency* (“*Notice*”) in this matter pursuant to I.R.C.P. 84(j)(1). The *Notice* gave the parties fourteen (14) days from the date of the *Notice* to file any objection to the agency record. On June 3, 2026, A&B Irrigation District filed *A&B Irrigation District’s Objection to the Agency Record* and on June 4, 2026, American Falls-Aberdeen Ground Water District filed *American Falls-Aberdeen Ground Water District’s Objection to Agency Record*. On June 17, 2026, the Director issued his *Agency Decision on Objections and Order Settling the Agency Record*. The agency record is now deemed settled.

YOU ARE HEREBY NOTIFIED that the settled record is being filed with the District Court, pursuant to I.R.C.P. 84(k) and the Court’s May 14, 2026 *Procedural Order*, through iCourt e-filing. A copy of the settled agency record has also been served upon the parties through iCourt serve.
