ORDER CONTINUING COMMENCEMENT HEARING

On January 3, 2025, the State of Idaho filed a Petition pursuant to Idaho Code § 42-1406D for the commencement of a general adjudication inter se of all rights arising under state or federal law to the use of surface and ground water for the Kootenai River basin water system and for the administration of such rights. A hearing on the Petition was held on July 15, 2025. At that hearing, the United States and the State of Idaho requested a thirty-day continuance of the hearing due to ongoing negotiations pertaining to proposed procedures for the deferral of de minimis domestic and stock water claims. The Court in an exercise of its discretion granted the continuance.

1. The deadline for the parties to file any proposed procedures for the deferral of de minimis domestic and stock water claims is August 18, 2025.

2. At the parties' request, the commencement hearing on the Petition is continued to August 19, 2025, at 1:30 p.m. (Pacific Time) at the Snake River Basin Adjudication Courthouse, 253 – 3rd Avenue North, Twin Falls, Idaho.
